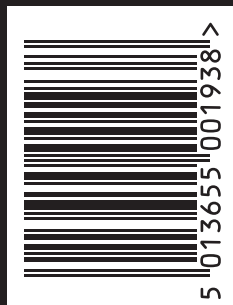

WASP NEST KILLER POWDER

For the control of wasps, ants, cockroaches, woodlice, fleas and other crawling insects in the home and garden



contains 0.46%w/w permethrin dusting powder

Wasp Nest Killer Powder is an insecticide powder for use against wasps, ants, cockroaches, woodlice and fleas in domestic premises. For use indoors and outdoors, on floors, around cupboards, in cracks and crevices, along runs in and around nests, and at points of entry to the property.

Directions for use:

Keep container tightly closed when not in use. Always shake the container well before and occasionally during use with cap closed. Shake pack gently, remove cap and pointing the nozzle downwards gently squeeze the container. Apply as a fine dust of powder to surfaces.

For Wasps: Apply dust liberally into the nests or in piles at the nests entrance. Application should preferably be conducted in an evening or on a dull overcast day when wasp activity is at a minimum. Care should be taken not to disturb the colony and you should not return to the nest until the wasp activity has ceased.

For Ants: Where possible open up the nests, dust well and tread down. Dust along ant runs, cracks crevices etc and apply liberally at entrances to nests. Where Ants are invading premises apply at entrance points such as doors, windows and air bricks etc. Repeat treatments as necessary.

For Crawling Insects: Apply to cracks, crevices and around entry points.

Store in a cool dry place. Replace cap after use.

Application Method: DUSTING POWDER
